

PMG UK Services & Fees

Effective July 1, 2018



PMG is the official grading service of the ANA and PNG.

For submissions to NGC International UK Ltd. (NGC UK) only.

US and world notes must be submitted on separate submission forms.

All fees are in pounds and include VAT.

Fees include round trip shipping and insurance between NGC UK and PMG Headquarters.

A £12 handling fee per invoice applies to all submissions.

A £7 adjustment fee will be charged for submission forms that must be modified prior to processing. This includes forms with more than one tier listed and bumps in tier levels due to undervalued notes. Choose only one tier per submission form. Catalog number (e.g. Pick, etc.) is required.

Unlimited WalkThrough	£90 + 1% FMV (£450 minimum fee)	Unlimited value.
High Value WalkThrough	£310	Notes valued up to £40,000.
WalkThrough	£175	Notes valued up to £20,000.
Express	£85	Notes valued up to £7,500.
Standard	£45	Notes valued up to £2,500.
Economy	£30	Notes valued up to £750 except errors, US BEP issued bonds, specimens, proofs, essays and/or notes not listed in <i>Paper Money of the United States</i> by Arthur and Ira Friedberg, <i>Standard Catalog of United States Obsolete Bank Notes 1782–1866</i> by James Haxby, <i>Confederate and Southern States Currency</i> by Grover Criswell, <i>Military Payment Certificates</i> by Fred Schwan, <i>Charlton Standard Catalogue of Canadian Bank Notes</i> edited by R. J. Graham and <i>Standard Catalog of World Paper Money</i> edited by Tracy Schmidt.
Economy Special	£35	Notes valued up to £750. All errors, US BEP issued bonds, specimens, proofs, US essays and/or notes not listed in Friedberg, Haxby, Criswell, Schwan, Charlton, or the <i>Standard Catalog of World Paper Money</i> .
Modern (1960–present)	£18	Notes valued up to £250. All notes issued 1960 to present except error notes, US BEP-issued bonds, specimens, proofs, US essays and/or notes not listed in Friedberg, Haxby, Criswell, Schwan, Charlton or the <i>Standard Catalog of World Paper Money</i> .
Bulk Submission		Applies to all bulk submissions: Notes valued up to £250. Fifty (50)-note minimum. The following notes are NOT eligible for bulk submission tiers: error notes, US BEP-issued bonds, specimens, proofs, US essays. Chinese notes issued from 1948 through the 1953 First Series notes (Pick numbers 800 to 859) and/or notes not listed in Friedberg, Haxby, Criswell, Schwan, Charlton or the <i>Standard Catalog of World Paper Money</i> .
Consecutive Notes	£13	All notes must be the same catalog number and all serial numbers must be in consecutive order. All vintage or modern notes are accepted provided they meet the bulk requirements above.
Mixed Vintage (Pre-1960)	£18	Notes may be a mix of catalog numbers and/or serial numbers.
Mixed Modern (1960–present)	£15	Notes may be a mix of catalog numbers and/or serial numbers. All notes issued 1960 to present are accepted provided they meet the bulk requirements above.
ADD-ON SERVICES	FEE PER NOTE (GBP)	DESCRIPTION
Early Releases / First Releases	Tier + £8	Use this service to receive the EARLY RELEASES or FIRST RELEASES designation for qualifying notes. Select only one. Visit PMGnotes.uk/cutoffdates for a list of eligible notes and submission cutoff dates.
PMG Oversize Holder	Tier + £12	Notes sized 195 x 120 mm to 205 x 220 mm must be submitted on a separate form.
Custom Holder		Available for multi-note sets, uncut sheets and notes larger than 205 x 220 mm must be submitted on a separate form.
Small	Tier + £22	Select Small Custom Holder for sizes up to 305 x 350 mm.
Large	Tier + £45	Select Large Custom Holder for sizes 305 x 350 mm to 400 x 470 mm.
ReGrade	Tier Fee	If you disagree with a grade assigned by PMG, you may submit the note for review for a higher grade. Note must be intact in its PMG holder. Also choose a grading tier according to note value.
Variety	Tier + £5	Additional attribution not mentioned in Friedberg, Haxby, Criswell, Schwan, Charlton or the <i>Standard Catalog of World Paper Money</i> .
Pedigree	Tier + £5	Reserved for information pertaining to private or public collection (e.g., <i>Ford Collection</i>)
REHOLDERS	FEE PER NOTE (GBP)	DESCRIPTION
ReHolder	£12	A note in a PMG holder can be submitted for placement in a new holder. Notes valued up to £7,500.
High Value ReHolder	£22	A note in a PMG holder can be submitted for placement in a new holder. Notes valued over £7,500.
OTHER SERVICES	FEE (GBP)	DESCRIPTION
Appearance Review	£0 per note	Review of a PMG note you believe is overgraded.
Internet Imaging	£4 per note	If chosen, PMG provides digital imaging for notes submitted under any of its grading and service tiers at £4 per note. Consists of accurate high-resolution images of the front and back of the note, shown encapsulated in its PMG holder. Applies to all notes on the form.
Return Packaging	£5 per form	Examples include Certificates of Authenticity and folders/boxes.
